# Church leaders applaud Knights in Supreme Convention remarks

## Ohio recognized for 12 new councils; 2 programs get international honors

Ohio's performance in establishing new councils during the 2009-2010 fraternal year brought recognition at the Awards Session of the Knights of Columbus Supreme Convention.

State Deputy Paul Upman, with his wife Lee, was presented with a special plaque by Supreme Knight Carl A. Anderson for achieving Supreme's New Council Development quota by establishing 12 new councils in the Ohio jurisdiction. The state was one of 29 jurisdictions order-wide to match or exceed new council quotas.

Upman credited Ohio's New Council Development Director Gabriel Minton for achieving the award.

Church hierarchy from throughout the Order applauded the Knights of Columbus at the 128<sup>th</sup> Annual Supreme Council Convention for its continuing work toward a Culture of Life.

"You are men of faith, men of charity, men of hope," said Most Rev. Pierre Morissette, bishop of Saint-Jerome, Quebec, and president of the Canadian Conference of Catholic Bishops. "We count on your leadership in so many ways."

His Eminence Gaudencio Cardinal Rosales, archbishop of Manila, The Philippines, echoed those thoughts. So did His Eminence Francis Cardinal George, president of the United States Conference of Catholic Bishops; Most Rev. Donald Wuerl, archbishop of Washington D.C., and many others.

Eight Cardinals, representing every nation in which the Order has a presence and Vatican City, were on hand for the annual convention, held Aug. 3-5 in Washington D.C. Nearly 80 Archbishops, Bishops and Abbots – and more than 100 priests -- also attended the convention.

Convention theme was "*I Am My Brother's Keeper*", a phrase in which



### A challenge to grow deeper in your faith

### Toledo vocations director leaves for Rome assignment

Fr. Adam Hertzfeld, who has served as director of the Office of Vocations for the Toledo Diocese, recently embarked on a new assignment in the English language section of the Vatican Secretariat of State in Rome. Fr. Hertzfeld told Knights of his new assignment while speaking at the Toledo Diocese Tour Program last July.

Regarding the assignment, Toledo Diocese Bishop Leonard Blair said "this is the papal secretariat which serves the Holy Father directly in his ministry to the universal church."

Ordained a priest in 2002, Fr. Hertzfeld is no stranger to Rome. He studied for five years at the Pontifical North American College in Rome as a seminarian, and returned there in 2005 to complete his license and doctorate in sacred theology after serving three years as associate pastor of Findlay St. Michael the Archangel. He was Director of Vocations since July, 2008.

Replacing him as vocations director is Fr. Charles Singler, who had been serving as rector of Our Lady, Queen of the Most Holy Rosary Cathedral as well as director of the Office of Worship and Liturgical Music. He continues as director of Worship and Liturgical Music.

## 2010 Matching Funds campaign ends Nov. 15; the goal is \$65,432

Don't forget Matching Funds!

That's the Ohio State Council's campaign to raise funds for Catholic education. It's a very simple campaign; a very important campaign, because it raises money to help better educate our children.

Councils, assemblies and Squires circles contribute funds to the campaign. The Ohio State Council matches the first \$25,000 that is contributed.

Those funds are given to the Religious Education Offices of Ohio's six dioceses. And they stay in the diocese in which they were collected.

The Religious Education Office directors, in turn, use those funds to purchase educational materials and equipment for their classrooms.

The Matching Funds Campaign started last Sept. 1. It will end Nov. 15.

So 2010 Matching Funds Chairman, State Advocate Bob Collins, asks councils, assemblies and Squires circles to contribute their funds as soon as possible. This year's theme is *Strengthening Our Faith Through Catholic Education*.

"Catholic education is so very important," he says. "That's why Matching Funds is so important."

Collins has established a 2009 campaign goal of \$65,432.10. He also has established other goals: 100% council participation, 200 councils having an increase in collections over last year, and 50 councils having an increase of at least 25% in collections.

Every Knight should have the opportunity to enjoy the social and fraternal times of the convention where one meets Knights and families from all over the United States and the globe – from Vermont to California, Poland to The Philippines. (I even met a person who resides in North Pole, Alaska).

Supreme Knight Carl A. Anderson repeatedly used in his 90-minute annual report to delegates and guests as he spoke about the Order’s Culture of Life projects and use of Culture of Life funds.

One of those was the Order’s presence in helping victims of the massive earthquake in Haiti last January, when thousands of people were killed or maimed. Anderson announced that Supreme Directors approved a new initiative, “Hope for Haiti’s Children”, explaining that the Order would work with the University of Miami/Medishare Hospital in Haiti’s capital of Port-au-Prince to “provide every child in Haiti who has lost an arm or a leg with the prosthetic device they need”.

“Each and every one of these children (approximately 800) will receive a new start in life thanks to the Knights of Columbus,” he said.

Anderson also reported on the Order’s initiative with the Wheelchair Mission, whereby local councils teamed up to provide 3,800 wheelchairs to those in need in 11 countries, including Haiti.

Anderson also emphasized use of Culture of Life funds in the Order’s Pro-Life Ultrasound Initiative, by which local councils partner with Supreme Council to purchase ultrasound machines for pro-life pregnancy centers across the United States.

“Recently we launched an initiative to save the lives of thousands of unborn children, one by one,” he said.

“Everyday, thousands of women are making individual decisions to have an abortion under great pressure, and often with little knowledge about the precious new human life within them. Modern ultrasound technology now provides clear, well-defined, full-color images of the child in the womb. The opportunity to see such images, and to understand in detail the development of a child even in the early weeks of pregnancy often has a dramatic effect on a woman’s decision regarding her pregnancy.”

Through the ultrasound program, Supreme Council provides a matching grant for every state or local council that raises half the cost of a new machine. Anderson reported that since start of the program, Knights in 25 states have enable the purchase of 53 ultrasound machines.

“Together, we have so far donated \$1,627,855 to buy these machines and it is the single largest and most important project of our Culture of Life Fund,” he reported.

Two poignant videos were shown – one dealing with the Knights’ response to the Haitian earthquake; the other with the Ultrasound Initiative. A third video dealt with the Order’s history.

## Changes made in Supreme Council leadership

Several changes, effective Sept. 1, have been made in the top leadership of Supreme Council. The changes were announced by Supreme Knight Carl A. Anderson.

Emilo Moore, who had served as Supreme Treasurer since October, 2009, becomes Supreme Secretary, succeeding Donald Kehoe, who retired. Charles Mauer Jr., who had been appointed Assistant Supreme Treasurer by the Board of Directors July 31, becomes Supreme Treasurer.

In addition, delegates to the Supreme Convention elected two new members to the Board of Directors: Michael Conrad, Past State Deputy of Nebraska, and Luzon Deputy Alonso Tan. Retiring were Supreme Directors Alberto Solis of The Philippines and John Harrison of North Carolina.

Anderson reviewed the Order’s projects, from vocations to military and veterans affairs, from support of the Squires and Boy Scouts to Coats for Kids, Special Olympics and Food for Families.

He reported that 74,000 Catholic men joined the Knights of Columbus last fraternal year, bringing total membership to more than 1.8 million.

He said 2009 was “our best ever for insurance sales, growing by 13.3%”.

And he said that in 2009 the Order donated more than \$151 million to charity, and members provided more than 69 million hours of volunteer help, according to the annual Survey of Fraternal Activity.

“My Brother Knights, I report to you today that our Order is strong; it is vibrant, and it is changing lives for the better in thousands of different ways around the globe. Our work continues. Our mission continues. Father McGivney’s mission continues.”

Just as he did at Ohio’s State Convention, Former Supreme Knight Virgil Dechant stressed *fortitude* to those assembled at one of the business sessions.

Stand up for your Church, he urged. “There are many hard times ahead for our Church. Signs of trouble are plain to see.”

Washington D.C. was a homecoming of sorts for Supreme Knight Anderson. He is a Past Grand Knight and Past State Deputy from the district.

The Opening Mass was celebrated at the National Shrine of the Basilica of the Immaculate Conception, with a couple dozen buses – escorted by volunteer Washington D.C. police – to and from the Marriott Wardman Park headquarters hotel. Main celebrant was Most Rev. Donald Wuerl, Archbishop of Washington D.C.

During the States Dinner – a fantastic gathering of K of C officials, Church hierarchy, delegates and guests – Anderson presented the Order’s highest award, the *Gaudium et Spes* Award, to His Eminence Jaime Cardinal Ortega y Alamino, Archbishop of Havana, Cuba. The archbishop, imprisoned for a period of time because of his faith, has guided the Cuban Church through often rough waters. The award, instituted in 1992, recognizes individuals who have made outstanding contributions to both the Catholic Church and to society.

Two Ohio councils were recognized for council programming.

Massillon Council 554 (Youngstown Diocese) was Third Place recipient in Supreme's International Council Activities Award competition. The council, with goals of improving community relations, getting inactive members involved and raising funds for charitable distribution, sponsored a circus – the first of its kind in Massillon in more than 30 years. The event raised \$5,000, with 434 members volunteering 3,107 hours on the project in one way or another.

St. Peter the Apostle Council 13984, Brook Park (Cleveland Diocese), was Fifth Place finisher in the International Church Activities Award category for its *Million Pennies for Heaven in the Year of the Priest* project. Special "Change Cups" were designed and made to accept donations in local shops and the parish, and proceeds also came from a pizza party, special fish fries and special "Vintage Vocations" wine tasting event. The \$10,401 collected was given to the *Pennies for Heaven* vocations fund.

Both projects had been recognized as "Best Activities of the Year" at Ohio's State Convention last May.

## Football Sweepstakes

the deadline is Oct. 29 to turn in tickets*

The deadline is approaching for the 2010 Football Sweepstakes.

All sold tickets must be turned in by Oct. 29.

The Football Sweepstakes is a great way, an easy way for councils to raise money for any use, according to Past State Deputy Gary Eckstein, the Football Sweepstakes chairman.

Tickets cost \$10.00 each. All tickets are valid for the last 10 weeks of the National Football League season, starting Oct. 31 and ending Jan. 3, 2011. There are 32 NFL teams. Each week each player has four teams. Each player has new teams each week. No other ticket has the same teams in any given week.

Total prizes are \$10,000. A total of \$1,000 in prizes is awarded weekly to the ticket holders with the four teams that score the most – or the least – number of points in that given week of games. Scores from the previous week's games will be used for teams that are not scheduled to play in any given week. It makes no difference whether teams win or lose.

The sold tickets must be sent to: PSD Gary Eckstein, 185 Wagon Trail South, Powell, OH 43065. Remember: he must receive them by Oct. 29.

Of the \$10.00 per ticket, the Ohio State Council keeps \$6.50. Councils can receive anywhere from \$2.50 to \$3.90 per ticket, based on the number of tickets sold statewide (a full breakdown of rebates was published in the July-August issue of the Buckeye Bulletin).

"The rebates are better than ever," says Eckstein. "For the second year in a row they have been increased.

"And councils can do anything they want with their earnings. They do not have to be earmarked for any specific cause.

"It's such a simple fund-raiser. Just sell those tickets at \$10.00 each and receive your rebates based on the number of tickets councils across the State of Ohio sell."

## The importance of the FAMILY

I want to thank all the council members who have helped and continue to support and promote the FAMILY. This is a very important unit and should be treasured by all of us.

Unfortunately, we only realize how important *family* is when we have funerals. You find yourself saying "If only I had spent more time with them" and then you swear that things will be different.

*Family* is the first persons we go to for support and sympathy. We also have fights and feuds with our family. We are disappointed, or embarrassed, by our family. We go to them when we need something as in times of personal or financial difficulties.

The point is that we should spend good and bad, boring and enjoyable, time with *all* our family members, not just when WE just need them. The Supreme form that you need to fill out to compete for this honor is found in the *Surge for Service* book. It must be filled out and sent to Supreme for your chosen family to be considered for the jurisdiction's monthly honor.

This is a different program activity than the State's, but it does garner the winner a very beautiful Holy Family Statue, a certificate, their name in the Columbian or Knightline, and a chance to be considered for the Supreme's Family of the Year.

Fewer and fewer men and women are answering the call to a religious vocation. Parents hesitate to encourage their children to become priests or religious sisters.

However, in today's society, there are many different vocations available to all of us – such as Eucharistic Ministers, Ushers, Lectors, Altar Servers, Greeters. Men under the age of 60 can aspire to be a Deacon.

# The secret of Membership Retention: Talk to them!

People ask: "How do I retain members?"

The answer is simple: **Talk with them!**

You don't make a "blind" phone call to recruit new members. So why rely on a "blind" phone call to retain them?

Personal, face-to-face contact is crucial to working through whatever obstacles may be preventing a member from retaining his membership, and even becoming a more active member as a result.

Other things to consider in retaining members are:

1. Establish a council Retention Committee, chaired by the Deputy Grand Knight and comprised of the council Trustees. Have several men from the committee reach out to the member and arrange a time to meet as a group and talk about the council's desire to retain him as a member.
2. Enlist the assistance of the member's original proposer who, if available, may still have a personal connection and can help work through obstacles to the member's continuation in the Order.
3. Utilize the "Power of 10" Program, initiated statewide by our State Membership Director

As you approach membership recruitment this fraternal year, please remember that you are not just recruiting new members. You are enabling the good works of the Order to continue and flourish. You are strengthening your council and making sure that the programs and efforts of current members will be continued for years to come. You are building a stronger Order and continuing the dream of Fr. McGivney to encourage all Catholic men to witness their faith through works of charity, done in the spirit of fraternal unity!

So, as you plan membership recruitment activities for your council this fraternal year, please consider the following recommendations:

1. Establish a **Council Admissions/Retention Committee**.
2. Plan and conduct a **"Membership Blitz"** for October & March (See your District Deputy for assistance and details.)
3. Plan and hold 1<sup>st</sup> degrees in your council or district in order to get interested candidates into the Order.
4. Establish a working **"Welcoming Committee"** to actively engage new members in your council programs after their 1<sup>st</sup> Degree.
5. Consider using the **"Power of 10" Program** to keep current members active and involved in your council.
6. If you have a council website, post information about both coming events and feedback about past ones, so members feel connected with the council. Also, identify your Council Membership Director as the "contact person" for individuals interested in joining and/or learning more about membership in your council.
7. Utilize your District Deputy and the Diocesan Membership/Retention Chairman in your diocese for assistance and direction in your recruitment efforts.
8. Actively plan and conduct Membership Activities listed in the General Program Book; then report them each month to earn credit and possible awards for your council's efforts. There are both State and Supreme Membership Recruitment incentives available to individual members and councils. Please take advantage of these "thank you's" offered to you and your council as a recognition for your efforts.

May each of you be blessed for the good work and effort that you engage in through your membership in the Knights of Columbus and consider inviting other Catholic men you know to join you!

### Special pin is offered for Anderson's 10<sup>th</sup> Anniversary

This fraternal year marks the 10<sup>th</sup> Anniversary of Carl A. Anderson as Supreme Knight. In honor of the occasion, Supreme Council will issue a commemorative pin for Knights who recruit 10 or more members between July 1 and Dec. 31, 2010. This recruitment includes new members, reapplications, readmissions and reinstatements.

4. Have options available when planning to meet with any member being considered for suspension. (e.g. payment plans, disability options, illness, active military duty, working out of town, in a nursing home, etc.).
5. Follow up with your initial meeting, when necessary, and communicate your sincerity in retaining the member.
6. Reach out to inactive insurance members still listed on your council roster.
7. Remind qualified members of their eligibility for "Life Member" and "Honorary Life Member" status, especially if they have or are close to meeting the criteria.

Finally, don't let money alone keep you from retaining members. Monthly or quarterly payments of dues as well as "relief funds" available for those sick, disabled or temporarily out of work should be made available to qualified members. Let them know that the Spirit of Fr. McGivney still exists in your council and that you are willing to work around financial setbacks to retain them as a member. Identifying these options is best done in a personal, face-to-face meeting with the member.

That's how we recruit and that is how we need to retain members.

# The bar is raised for Ohio's Pennies for Heaven program

During the annual Summer Tour Programs held throughout Ohio last July, the bar was raised for the 2010-2011 fraternal year *Pennies for Heaven* campaign.

"Ninety thousand dollars (\$90,000) is the next step for Ohio Knights. It's a realistic goal that can become a reality this fraternal year," says State Secretary Dave Helmstetter, who is this year's *Pennies for Heaven* chairman.

Ohio Knights established a record last fraternal year, exceeding \$83,000 -- thanks to outstanding efforts by Knights in the Cleveland and Columbus dioceses. Cleveland Knights collected nearly \$30,000, while Columbus Knights topped \$20,000.

The key, according to Helmstetter, is increasing the number of councils involved with the program. Sixty percent -- 224 out of 367 councils -- participated in the 2009-2010 program. Raising the level of participation to 300 councils would allow the state to shatter yet another fundraising record this year, believes Helmstetter.

Working *Pennies for Heaven* in a local council, or parish, is simple. "All you need to do is pass the jug -- got vocations?, then pass the jug at every council event or any opportunity presented. It's a simple exercise that helps vocations in your diocese," Helmstetter said.

## Archbishop Elder Council provides help for Operation Soccer Ball charity in Iraq

When a young man from the Cincinnati area became involved in a special project to help the youths of Iraq while on duty with the U.S. Army, Knights of Archbishop Elder Council 1195, Cincinnati, were among the first to help.

Ben Franzosa grew up as a St. Gertrude, Cincinnati, parishioner and of its CCD program, and is a graduate of the Milford schools and of the University of Dayton. At Dayton, he participated in the ROTC program and was commissioned in the U.S. Army as a 2<sup>nd</sup> Lieutenant.

His unit, the 543<sup>rd</sup> Military Police Company, 10<sup>th</sup> Mountain Division, based at Ft. Drum, N.Y., was sent to Iraq in July, 2009, for 12 months. He's back from that duty and is stationed at Ft. Drum.

While stationed in Diwanayah, Iraq, Lt. Franzosa learned of Operation Soccer Ball, a charity started by another Military Police officer to collect donation of soccer balls and give them to Iraqi youngsters for their enjoyment and to provide hope for their future. When that officer's tour of duty ended, Lt. Franzosa volunteered to take over the responsibility, and he established a goal of distributing at least 1,000 balls.

His parents, Rick and Mary Franzosa, became involved, and through word of mouth, donations were received from many sources.

"Through our parish church, St. Gertrude," we connected with Frank Merle (of Elder Council), and he and the Knights of Columbus were the first to donate," said Rick.

Elder Council sponsored a special St. Patrick's Day Dinner. That event, and other means, provided funds to purchase soccer balls.

And, yes, Lt. Franzosa exceeded his goal by quite a bit, distributing more than 2,500 soccer balls to the youngsters of Iraq.

It was another way the charity of the Knights of Columbus helped others.

Many councils do more than just pass the jug. They involve the entire council or their parish in an activity. Those activities can be reported under the Church Activities program and enable councils to collect program points. The points can be earned through Activity #10 of the State Vocations Program, which is part of the Church Activities Program.

"Councils have really shown their creativity in developing activities aimed at supporting vocations," said Helmstetter, who emphasizes councils should strive to reach the \$1,000 plateau and receive recognition at the annual state convention.

For example, St. James Council 2299 in Logan has designed a "Challenge Coin" supporting vocations. Co-Chair Don Gable says the coin could make for an ideal fundraiser for other councils in Ohio. "We're offering them to any council in Ohio at a reasonable rate. These coins would make a good way to increase their Pennies for Heaven program," he said. Gable can be contacted at (740) 385-5107.
